The training sessions included a number of specific topics such as: designing of free zones, trade facilitation, Customs and regulatory framework, improving logistical services, marketing, Incentives framework and Investor attraction.

### AFZO WORKSHOP 2 LEGAL FRAMEWORK FOR FREE ZONE Tangier - MOROCCO



Moderated by **Mr Amir JAHANGUIRI** Partner-Wilkie Farr & Gallagher

Mr Amir presented the different legal and institutional frameworks of free zones:

- He descraved major components of traditional free zone package, its incentives & Requirements. He detailed also new legal framework models that are being implemented by free zones based on the liberalization of the traditional set of privileges and simplification of the traditional legal framework

- Mr Amir presented the approach and advantages of the implication of the private sector in free zones development. He shared the example of Ghana free zone program as legal and institutional framework designed to private participation.

### AFZO WORKSHOP 3 AFRICAN ECONOMIC ZONES BUSINESS CASE REVIEW Nairobi - KENYA



Moderated by **Mr Youssef IMGHI** General Manager, Tanger Med Engineering

### Topics :

- Interactive session to debate an approaches to free zone initiation and development phases,
- Presentation of the Roadmap for successful free zones
- Review of free zones detailed cases from selected African countries

Mr Imghi presented the most common expectations of investors to re-export the lowcost manufactured goods and the different types of free zones and its characteristics. He shared examples of :

- Export Processing Zones of KENYA
- Special Economic Zone of Nkok GABON
- Status of Free Enterprises Export (EFE) Senegal

Mr Imghi focused on the success factors for free zone such as : the investment climate, the geographic location, the incentives offered to investors and the free zone program.

He detailed the free zones development process

starting from the General Studies (financial, technical and environmental studies), site selection and setup of Strategic framework (regulatory, customs tariffs and tax incentives,...)

# AFZO WORKSHOP 4 FREE ZONES OF THE FUTURE Dubai - UAE



Moderated by **Dr Mohan GURUSWAMY** Chief Knowledge Officer, World FZO

### Topics :

✓ Selected Review of Free Zones Models from other continents

According to Dr Mohan, a free zone should be in a permanent interaction with external changes and technologies development, that can have a huge impact of free zones industries (such us 3D printer, artificial systems, green zones, smart zones...).

In this sense, a free zone should plan future and anticipate customers' expectations through innovative incentives, incubation centers (winwin situations), facilitator role of government, and investor business enhancement.

He concluded that free zone sustainable development is relied to three major conditions:

- A Flexible framework to easily adjust policies,
- keep an ear to market understanding and sector changes,
- Dynamic capabilities.

## AFZO WORKSHOP 5 **PUBLIC AND PRIVATE PARTNERSHIPS FRAMEWORK TO SUPPORT ECONOMIC ZONES DEVELOPMENT** Dubai - UAE



Moderated by **Mr Mehdi TAZI RIFFI** CEO, Tanger Med Group

### Topics :

- ✓ The role of PPP in developing Economic zones in Africa
- ✓ Types of PPP projects within the Economic zones context

Mr Tazi defined the PPP as a tool to allow a good balance between private and public objectives to support investment undertaking. The PPP projects could be developed for:

-Public provision of off-site infrastructure and facilities

-Assembly of land parcels by the government for lease to private zone development groups

-BOT on-site and off-site zone infrastructure and facilities, with government guarantees and/or financial support.

-Contracting private management for government-owned zones (management contracting), or lease of government zone assets by a private operator

Mr Tazi explained how PPP could make a balance between Risk Sharing, Mobilization of Financing Resources and Investment CAPEX. The PPP polices has to consider conjunction of development objectives with profitability, risk management and mitigation, governance model and social responsibility.

# Mr Amir JAHANGUIRI, Partner, Willkie Farr & Gallagher LLP:

Mr Amir Jahanguiri states that the investment incentivesscheme and legal framework contributes to set-up of a business-friendly environment within Economic Zones and free zones. Local investment climate and governance are key fundamentals for the success of Economic zones projects.





#### Mr Louis DUBOIS, Avocat of Counsel, Dentons

Mr Louis Dubois explained the prerequisites for the creation of an Economic zone project in Africa: Besides the infrastructure set-up and legal and administrative framework, the Economic zone developers should deploy all efforts in supporting technical operation, facility management and the One-Stop-Shop activities.

## AFZO WORKSHOP 7 **ROADMAP TO DEVELOP ATTRACTIVE VALUE PROPOSITION FOR ECONOMIC ZONES AND FREE ZONES** Abidjan – IVORY COAST

### Mr DOUGLAS ALOIJSIUS FREDERIK VAN DEN BERGHE, CEO of ICA EMEA

Mr DOUGLAS presented the Innovation Incentives for "New Generation" FZs fostering the role of one stop services and ensure a "soft landing" of the investment project and further expansion.

He also detailed the concept of NxtZones that consist on developing a Free Zone Real Estate Technology Concept that creates unique office space and facilities in a number of Free Zones around the world.





### Mr Youssef IMGHI, General Director at Tanger Med Engineering

Mr. Youssef IMGHI described the best practices and standards applied for the implementation of an Economic Zones. Throught "major milestones : Technical survey, design and Engineering that comprehends: Business and feasibility study, geotechnical, environmental and social impact assessment, Master plan and technical analysis... Project Execution, construction and development works...

## AFZO WORKSHOP 8 BUILDING CAPACITY MANAGEMENT IN THE DEVELOPMENT OF ECONOMIC ZONES AND FREE ZONES Accra - GHANA

Mr Andrew CLUTZ, Director, Corporate Investment & Analytics, Conway, Boston

After presenting the different terminologies & concepts of Economic Zones and Free Zones, Mr Andrew pointed out the international context and emerging trends of trade and investment in which Economic Zones are used as policy instrument is changing. He also highlighted the Key Instruments for FDI attractiveness and Industrial development in Economic Zones and Free Zones in Africa, through a corporate perspective, government perspective, Nxtzones and integrating Industry 4.0 into SEZ Management.





### Mr Amine MALTI, Project Manager, Tanger Med, Tangier, Morocco

Mr Amine shared the key instruments for a competitive facilitation framework through five main insights : Incentives, talents, Free Trade Agreements, one stop shop and infrastructure.

He ended his presentation highlighting TangerMed environmental priorities and main achievements, with the objective to ensure coherent management of its territory in respect of natural heritage, reduce the environmental impact of port And industrial activities, optimize and reduce energy consumption and co2 emissions and a better management and revalorization of waste.

### AFZO WORKSHOP 9 Social & Environmental Sustainability: Emerging ISSUES FOR INDUSTRIAL & INVESTMENT DEVELOPMENT Accra - GHANA



Mr Dauda Foday Suma, Senior Industrial Advisor at Global Green Growth institute in Ethiopia

Mr Dauda presented how Green Industrialization and Sustainable development can foster Investment

#### promotion in Africa.

Through presenting trends in Global Emissions, Emissions by Gas and by Sector, he raised the public awareness regarding Climate change impacts and trends in Emissions from the Industrial Sector.

Mr Dauda pointed out the importance of

adopting eco-friendly measures, and mentioned stressed how Greenhouse gases Mitigation Options for Industry, Green Growth and Low-carbon can make Competitive Green SEZs, enhancing competitiveness through cost reductions, new business opportunities, better environmental compliance, health benefits- better air and water quality, better working conditions/environment and reducing wastes.

### AFZO CONFERENCE 1 THE ROLE OF ECONOMIC ZONES AND FREE ZONES IN ATTRACTING FOREIGN DIRECT INVESTMENT Abidjan – IVORY COAST



Mr Pierre GUISLAN, Vice president of the African Development Bank Group

Mr Pierre GUISLAN underlined the involvement of the private sector in supporting government initiatives: "Successful Economic Zones requires strong economic governance to attract private investors and FDI".

Mr Pierre GUISLAN identified two major opportunities for Special Economic Zones and Free Zones projects in Africa:

**1** African Continental Free Trade Area (AfCFTA) adopted in Kigali , on March 2018, with the objective to create a single continental market where Economic Zones has to play an important role.

**2** The initiative of AfDB called "Staple Crops Processing Zones" that focused on creating new economic zones in rural areas and develop processing activities based on domestic resources.

**Ms Félicia DJIBO, Director Consulting and Risk Advisory at Deloitte Francophone West Africa** Ms Félicia DJIBO stressed the main challenges of Economic Zones such as market demand assessment, governance, infrastructure, setup favorable social economic environment and Planning. She also pointed out the role of government and African leaders to balance and prioritize between developing Economic Zones projects and supporting social initiatives.

#### Mr Richard OBIANU, Assistant General Manager, at Nigeria Export Processing Zones (NEPZA)

Mr Richard OBIANU shared the experience of NEPZA in attracting investments, creating jobs and deploying positive spillovers in the Nigerian economy. He described the key fundamentals in implanting dedicated regulatory framework for Free Zones and Export Processing Zones. Mr Gustavo GONZALEZ DE VEGA, Vice President Association de Zonas Francas de Las Américas (AZFA) :

Mr Gustavo GONZALEZ DE VEGA shared major achievements of the association AZFA reaching 200 members and over 20 years experience supporting Latin American Free Zones development.

Mr Gustavo GONZALEZ presented the "Atlantic Platform Exchange Project" to strengthen relationships and synergies between Latin American and African Economic Zones and Free Zones. This project consists on creation of corridors connecting Free Trade Zones from Latin America, Africa and Europe with the involvement of government representatives and Investment-Trade promotion authorities.

### Mr Aboubaker OMAR HADI, Chairman, Djibouti Ports and Free Zones Authority :

"Djibouti Ports and Free Zones Authority (DPFZA) developed the concept of "the port inside the Free Zone" to reduce logistic costs improve administrative processes and foster customs regulations with the objective to attract Foreign Direct investments".

# Mr Mehdi TAZI RIFFI, CEO of Tanger Med Port and Zones :

"The key ingredients for successful of Special Economic Zones are:

**1** Specific and dedicated business environment and regulatory framework such as : one stop shop, favourable environment for investments, incentives and facilities...

**2** Integration with a comprehensive infrastructure and logistic development plan.

**3** Focus on defining the main activity sectors for the zonethrough clustering approach to attract FDIs and enhance industrial competitiveness".

# AFZO CONFERENCE 2 CHALLENGES AND OPPORTUNITIES FOR AFRICAN ECONOMIC ZONES AND FREE ZONES Abidjan – IVORY COAST



### Pr Jhon C.ANYANWU , Lead Research Economist, Macroeconomic Policy, Forecasting and Research Department at the African Development Bank Group (AfDB):

Mr Anyanw presented the key Investment drivers in economic zones and free zones projects adopting « holistic » and « one stop shop ». He also stressed innovative sources of finance for funding projects in Free and Economic Zones in Africa such as PPPs, corporate bonds, private equity funds, ....

Pr Jhon also highlighted the role of the AfDB in providing technical assistance and policy advice, financing PPP projects, and promoting capacity building among other services.

### Mr. Adil CHIKHI, Director ICA SEMED at The European BankforReconstruction and Development (EBRD) :

Mr Adil CHIKHI underscored the EBRDS's commitment to help unlock the economic potential of the African continent. Overcoming challenges of Economic Zones and Free Zones in attracting FDIs, creating jobs and promoting financial inclusions. He also shared details on EBRD approach in supporting industrial projects in eastern Europe and north Africa. Success stories has also been demonstrated in promoting modern industrial sector such as the automotive industry in Morocco, Tunisia and Egypt.

# Mr Filippo MAURI, CEO at International Logistic Expert :

Mr Filippo MAURI highlighted the importance of the integration of exogenous factors in developing strategies for Economic Zones and Free Zones in Africa. The optimization of logistic coast and improvement of supply chain processes are key successes factors for industrial capacity building. Mr Ahmed BENNIS, Director International Business Development at Tanger Med :

Mr Ahmed BENNIS explained that fundamentals behind the development of successful value proposition for Economic Zones and Free Zones in Africa are:

- Infrastructures set up applying international standards that fit to industrials needs.
- Skill set development, training and sustainable social environment.
- Government involvement through supporting initiatives and dedicated framework.
- Genuine approach in attracting investments and supporting.

### Mr Youssef OUATTARA, Agency for the Management and Development of Industrial Infrastructure (AGEDI), Ivory Coast :

"The government of Republic of Ivory coast has initiated several reforms designed to Economic Zones in order to facilitate administrative procedures and enhance transparency process management ... the government has set objectives to balance between supporting social initiatives and accelerate industrialization and Economic Zones development...".

# Mr Adel MOHSEN, The Executive Chairman of the General Authority for Investment and Free Zones (GAFI), Egypt.

"We believes that constructing new free zones helps to improve the investment climate of the country as it ensures the free movement and trade of goods, thus establishing Egypt's reputation as a great business hub ... the Egyptian government has established nine free zones distributed all over the republic and supplied with facilities and essential infrastructure services."

### AFZO CONFERENCE 3 **PROMOTING REGIONAL VALUE CHAINS IN AFRICA ESTABLISHMENT OF AN AFRICAN SEZ NETWORK & KNOWLEDGE PLATFORM** Addis Ababa – ETHIOPIA

Addis Ababa, Ethiopia – 21 November 2018. The Department of Trade and Industry of the African Union Commission organized the Africa

"Promoting Regional Value Chains in Africa: A Pathway for Accelerating Africa's Structural Transformation, Industrialization and Pharmaceutical Production".

Industrialisation Week (AIW) under the theme:

500 participants attended the AIW 2018. The afternoon of 18th November 2018 was dedicated towards the Official Opening Ceremony by the H.E Paul Kagame President of the African Union, High Level dignitaries from Member States, RECs, United Nations Agencies, Diplomatic Corps and Private Sector will attend the launch the Africa Industrialisation Week and the commemoration Africa Industrialisation Day 2018.

The participants drew from AU Member States, Private Sector representatives, Regional Economic Communities, AU Commission, NEPAD, UNIDO, GIZ, EU, UNDP, UNECA, UNCTAD, Afreximbank, AfDB, AFZO, Academia, civil society, Research Institutes and Think Tanks, independent experts and researchers.

### AFZO 3<sup>rd</sup> ANNUAL MEETING ECONOMIC ZONES AND FREE ZONES' CONTRIBUTION TO SUSTAINABLE ECONOMIC DEVELOPMENT IN AFRICA Abidjan – IVORY COAST

After two first editions in Tangier, Morocco, in 2015 and 2016, the 3rd Annual meeting of Africa Free Zones Organization has successfully concluded its work on Saturday 22nd September 2018, in Abidjan, Ivory Coast.

This meeting gathered 100 C-Level participants, 18 international experts, and 35 Economic Zones and Free Zones to discuss "Economic Zones and Free Zones contribution to sustainable Economic development in Africa". More than 30 countries were represented during this event:

Burkina Faso, Botswana ,Chad, Uganda, Djibouti, Egypt, Kenya, Ethiopia, Ghana, Guinea, Ivory Coast, Libya, Mali, Mauritania, Nigeria , Sudan, Senegal, Togo, etc.

The participants had the opportunity to develop network and business alliances with Economic Zones and Free Zones community.

The AFZO 3rd Annual Meeting started with Welcoming and Opening Speech by his Excellency Mr Soulemane DIARRASOUBA Minister of Industry Trade and SMEs Development of the republic of Ivory Coast, and Mr Fouad BRINI, President of Tanger Med.



His Excellency the Minister of Industry of Republic of Ivory Coast, **Mr Souleymane DIARRASSOUBA** welcomed the holding of the 3rd Annual Meeting of Africa Free Zones Organization in Ivory Coast, Abidjan.
