African economic zones on CNN-Connecting Africa

New greenfield investment project announcements in Africa were still down -7% in 2021, especially in the GVC-intensive activities that many special economic zones (SEZs) depend on for investment promotion.

But African SEZs also have important opportunities. Project finance in infrastructure is up, with industrial real estate among the fastest growing sectors. Diversified activities, such as agro-processing zones, can counter the slump in GVCs, and AfCFTA - African Continental Free Trade Area is a long-term chance for investment in regional value chains.

These were key themes at the Africa Economic Zones Organization (AEZO) annual meeting, covered in a CNN special on AEZO Youtube channel.
